As part of its review process for manuscripts submitted to its journals, the Institute of Mathematical Statistics has arranged for a permanent archive for computer code and data supplements. These supplements will be reviewed as part the submissions and at the time of acceptance of manuscripts for publication editors will authorize the archiving of supplements. These supplements will be linked to the manuscripts online via URLs and will following publication be linked to the electronically archived versions of the papers.

Authors will enter into an agreement directly with Statlib regarding the archived materials giving permission to redistribute the software and data. authors may retain the copyright just so long as they clearly state that the materials can be freely used for non-commercial purposes and can be freely distributed. Authors who are not the original authors of the submission must obtain the original author's permission before submitting the software or data.

Each submission needs to be formatted to comply with the following Statlib requirements:

1. Summary A short summary must be provided with information about the submission. This should be just a few (not more than two 80 char lines) lines to be placed in the index file. It should concisely describe what your submission does. See the current general index for the format and length of summaries. Please make this the first item in your submission (so that it can be easily found).

2. Format Supplementary material hosted by StatLib may include data, graphics, software, and documentation, not text material such as additional proofs or appendices.

The technical standards for this material are as follows:

- Plain text, comma-delimited files for data (.CSV files).
- Plain text ASCII files for software source code.
- EPS and or JPEG images for graphics files.
- The encoding of text files should be UTF-8.
- PDFs may be provided, preferably with LaTeX source code if available.
- If you are submitting multiple related files, they should be packaged in a reasonable way, e.g., by creating a compressed archive (ZIP, RAR, etc.) and include a README file that describes what the submission does and how to use it, and a manual page.
- PLEASE INCLUDE YOUR NAME AND E-MAIL ADDRESS PROMINENTLY IN YOUR SUBMISSION AND INDICATE IF YOU ARE WILLING TO HELP PEOPLE WHO HAVE PROBLEMS.

3. Permission to redistribute A statement (which should also be part of the information to be shared) that explicitly gives permission to redistribute the archived materials (see above).

Authors retain responsibility for all materials submitted. Statlib will not test any submitted software in any way, nor will it provide editorial comments about the quality of the software. Rather Statlib will merely redistribute whatever material is submitted.

Updating/correcting code and data submissions The purpose of the IMS/Statlib archive is to provide a permanent and accessible record of the original materials linked to the published paper. In the event of corrections or updates to the materials, these require permission from the relevant editor before posting in the archives and a separate signed agreement. Material cannot be withdrawn from the archive except in exceptional circumstances with permission of the IMS executive.
